<u>Auditors in NSE-listed companies in 2013-14- Big 4 dominate with 27 per</u> <u>cent share by volume and 24 per cent share by fee:</u> <u>www.nseinfobase.com-</u> Developed & Powered by PRIME Database

The analysis is based on Auditors in all 1,437 NSE listed companies for the financial year 2013-14.

Number of Audit firms

As many as **781 audit firms audited the 1,437 companies**. This implies that, on an average, **an audit firm audited 1.83 companies**. However, the **top 10 audit firms accounted for audit of as many as 524 companies**. Leading the league table was the Deloitte group with 149 companies. The Big 4, between them, handled a high 385 assignments, or 27 per cent of the total.

<u>Total Audit Fee</u> The total audit fee paid out by companies was Rs. 1,598 crore (data based on 1,404 companies for which Audit Fee/Total Fee data is available*). This was in comparison to Rs. 1,273 crore paid out in the previous financial year 2012-13.

The average Audit Fee was Rs. 1.14 crores.
