BIG 4 CONTINUE TO DOMINATE AUDIT SPACE IN LISTED COMPANIES WITH 26 PER CENT SHARE BY VOLUME AND 27 PER CENT SHARE BY FEE: PRIME DATABASE

The Big 4, between them, handled a high 378 assignments of the total 1,450 companies, or 26 per cent of the total. Their dominance was even stronger in the Nifty-500 subset wherein they handled 229 of the 500 audits or 46 per cent of the total.

On an overall basis, as many as **791 audit firms audited the 1,450 NSE-listed companies in 2014-15**. This implies that, on an average, **an audit firm audited 1.83 companies**. However, the **top 10 audit firms accounted for audit of as many as 521 companies or 36 per cent of the total**. Leading the league table was the Deloitte group with 149 companies, followed by EY Group (108), Price Waterhouse Group (65) and KPMG Group (58).

Total Audit Fee

The total audit fee paid out by companies was Rs. 1,727 crore (data based on 1,421 companies for which Audit Fee/Total Fee data is available**). This was in comparison to Rs. 1,607 crore paid out in the previous financial year 2013-14, an increase of 7 per cent. The average Audit Fee was Rs. 1.21 crores.

Ranking by Audit Fees

Deloitte Group continued to lead with a total audit fee of Rs. 225.35 crore. The top 10 auditors by fee along with the change from previous years is as follows:

<u>Total Overall Fee</u>
The total overall fee paid out by companies was Rs. 2,000 crore (data based on 1421 companies for which Total Fee data is available). This was in comparison to Rs. 1,875 crore paid out in the previous financial year 2013-14, an increase of 7 per cent. The average Total Fee was Rs. 1.41 crores.

The Deloitte Group again led with Rs. 303.17 crore, followed by EY Group at Rs. 121.23 crore, KPMG Group at Rs. 99.38 crore and PWC at Rs. 65.61 crore.
